2. Type of personal data

3. Purpose and Legal basis

3.1 We process your personal data which are necessary for the implementation of pre-contractual measures with Messe Berlin GmbH. In particular, we use your contact data to provide you with organizational information regarding the course of the event or similar (legal basis: art. 6 par. 1 p. 1 b GDPR).

3.2 Furthermore, we use your personal data for the purpose of contacting you in order to provide you with current information and tips on ILA Berlin at regular intervals. The basis is Art. 6 par. 1 p. 1 lit. f DSGVO. The legitimate interest lies in the direct application for the ILA Berlin. Please note that you have the right of objection in this regard (see "Your rights" below).

4. Your rights

You can assert the following rights of data subjects: The right to information, deletion and correction of your personal data, the right to data transferability, as well as the right to limitation of processing. For reasons arising from your particular situation, you have the right to object at any time to the processing of personal data concerning you, which was carried out on the basis of the above-mentioned point 3.2. If you believe that data processing violates data protection law, you have a right of appeal to the competent supervisory authority.

5. Duration of storage

Insofar as the processing takes place on the basis of Art. 6 par. 1 p. 1 f DSGVO, the data will be deleted upon receipt of your objection.
